

Reference Memorandum for Agenda 4**Dividend Payment History**

Since 1987, the year that the Company was registered in the Stock Exchange of Thailand, there was a policy to pay dividends based on approximately 60 percent of the net income after taxes for each fiscal year. The Company had paid dividends every year, with the exception of the year 1997 when there was the economic crisis in Thailand, and in 2018–2020, due to continuous loss in operation of the Company. as per details shown below.

Board of Directors Opinion: In 2025, the Company had a net loss of 40,389,373 Baht however, when combined with the cumulative profit, the profit amount for 2025 dividend payment calculation is 369,213,510 Baht. The Meeting should approve of the dividend payment of 0.50 Baht (50 satang) per share, for a total of 25,000,000 Baht, with payment date on Monday, 25 May 2026.
